## WHAT DOES PEAPACK-GLADSTONE BANK AND ITS AFFILIATES (INCLUDING POINT VIEW WEALTH MANAGEMENT INC.) DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and account balances
- Transaction history
- Wire transfer instructions

### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Peapack-Gladstone Bank and its affiliates choose to share; and whether you can limit this sharing.

<b>Who we are</b>	
<b>Who is providing this notice?</b>	Peapack-Gladstone Bank. This notice applies to Point View Management, Inc. an affiliate of Peapack-Gladstone Bank.
<b>What we do</b>	
<b>How do Peapack-Gladstone Bank and its affiliates protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How do Peapack-Gladstone Bank and its affiliates collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>▪ Give us your contact information</li> <li>▪ Open an investment account or apply for a loan</li> <li>▪ Tell us where to send your money or make a wire transfer</li> </ul>
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>▪ Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>▪ Affiliates from using your information to market to you</li> <li>▪ Sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account.

<b>Definitions</b>	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ <i>Our affiliates include companies with a Peapack-Gladstone Bank or PGB name; financial companies such as Peapack-Gladstone Bank, PGB Trust &amp; Investments of Delaware, Peapack Capital Corporation, Murphy Capital Management Inc., Quadrant Capital Management LLC, Lassus Wherley, &amp; Point View Wealth Management Inc.</i></li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ <i>Peapack-Gladstone Bank and its affiliates do not share with nonaffiliates so they can market to you.</i></li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ <i>Our joint marketing partners include financial services and credit card companies.</i></li> </ul>

### Other important information

**For California Residents:** Under California law, Peapack-Gladstone Bank and its affiliates will not share information they collect about California residents with companies outside of our corporate family, unless the law allows. Peapack-Gladstone Bank and its affiliates will limit sharing among our companies to the extent required by California law.

**For Vermont Residents:** Under Vermont law, Peapack-Gladstone Bank and its affiliates will not share information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont Law, unless you authorize us to make those disclosures. Peapack-Gladstone Bank and its affiliates will limit sharing among our companies to the extent required by Vermont law.
